2024/5 GTCL Budget	Michael presented the proposed budget (prepared by Treasurer Anna Rodin.) With a current balance of \$3254, projected income of \$1799, and projected expenses of \$3459, a balance of \$1594 is expected at the end of the fiscal year.	
	Alex Ferreira asked whether the Toronto Youth Chess Championship could be added to the list of events the GTCL supports. Michael Barron moved that this be added to the GTCL budget.	Passed unanimously.
Other Business	Salim Belcadi suggested that GTCL should have a liaison with different levels of government to help support its events.	
	Alex Ferreira proposed that the Toronto Chess Centre could operate the Toronto Youth Chess Championship at some point in November, to avoid conflict with other youth activities. Corrina noted that Yuri Ledbedev had been running an event with the same name (although not sanctioned by GTCL.) This hasn't run for several years, but Corrina	
	advised that Yuri should be told if GTCL was going to be running TYCC.	
Amendment to Budget	This brought up more discussion. Michael Barron pointed out that youth events are typically attended by players who do not pay CFC memberships, and therefore do not contribute to the GTCL budget. Metion: GTCL should financially support an event such	Motion carried.
	Motion: GTCL should financially support an event such as TYCC without CFC membership requirements.

New Business	Ilia noted that anti-cheating measurements, specifically for senior-only events, damaged the social aspect of such events. Seniors who attend such events, which have little to no money attached with them, are interested in playing in a more social environment. Rules that forbid players from speaking with one another while games are in play damage the social aspect of such tournaments. It was generally agreed that if such events were not	
	FIDE-rated, anti-cheating rules could be gently relaxed, provided that conversations outside the playing hall were in English only, to determine that no chess is being discussed, and that games in play should not be displayed.
